ITS Information/Guidelines:

Dear Participant,

Thank you for your interest in performing in the 2021 IACA Talent Show!

Contestants (or a parent of a contestant) must select an Age Group and a Category in which they are going to perform. See Age Groups and Categories below and request ITS Registration Form by sending an email to IACAGJC@gmail.com or call a team member listed below. A contestant must submit completed Registration Form on or before **March 31st, 2021**.

Round One – All participants will enter in the audition process by submitting 1-minute-long video of their talent in the selected category to IACAGJC@gmail.com on or before **April 5th, 2021**. ITS judges will short list entries based on quality of talent and performance.

Round Two (Semi-Finals) The short-listed talents will be invited to perform the same talent for a minute and half LIVE on Zoom on **April 9th, 2021**. ITS judges will shortlist contestants for next stage.

Round Three (Final) - In the Final round, selected contestants will perform talent in the chosen category for 2 minutes LIVE on Zoom on **April 11th, 2021**. ITS judges will select the top 3 winners from each Age Group and announce the winners.

NB 1: Non-refundable Registration Fees \$15 per contestant if either a contestant or his/her parent is not a current member of IACA. Registration Fees is Waived for a contestant who is a member of IACA (or his/her parent/s is a current member).

ITS RULES & REGULATIONS

1. Participants can enter ITS as a solo act only.
2. Acts must be no more durations indicated in each round above (1, 2 and 3).
3. If selected, a participant must be available physically to participate in Zoom for Round 2 and Round 3.
4. We want participants who enter this show to exhibit their talent. Talents might include (but are not limited to) singing, dancing, instrumental music, skits, magic, juggling and other etc. (as per ITS flyer). Lip-syncing or singing along with the voice on tape is not allowed. Live instrumental accompaniments are allowed if the contestant's performance is not subdued. Karaoke tracks are allowed without dominating vocal tracks if a contestant is singing and without dominating instrumental tracks if contest is playing an instrument.

The whole idea is to allow the judges to evaluate a contestant's performance.

5. No act will be considered if it does not meet the judges' standards of appropriateness for IACA in terms of language, subject matter, and attire. Acts having ANY DOUBTS about the appropriateness of their material would be well-advised to discuss this with the talent show committee BEFORE AUDITIONING.
6. Participants are responsible for their own music, props and costumes. Although complete costumes and props are not necessary, the complete and polished act has a greater chance of success.
7. Waiver of Liability & Hold Harmless Language – In consideration of requirements of IACA TALENT SHOW REGISTRATION FORM by India American Cultural Association (IACA) to permit me/my child to participate in the IACA TALENT SHOW 2021 (ITS), and as a consideration for my interest to participate in the Program, I hereby, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Program, and do hereby release and forever discharge IACA located at 1281 Cooper Lake Road, Smyrna GA 30082, their Organizing Committee and IACA ITS Team/volunteers for any physical or psychological injury, that I may suffer as a direct result of my participation in the aforementioned Program.
